### **GENERAL NOTES**

1. All materials should be new and good quality.

2. During construction, the contractor shall examine adjoining and connecting work, and verify dimensions necessary for the proper installation of work.

3. Before starting construction, the contractor shall examine adjoining and connecting work, and verify dimensions necessary for the proper installation of the work.

4. All work shall be of the highest quality and standards as recognized by the industry. 5. The contractor shall maintain the site and adjacent areas in a clean, neat, and orderly manner. The contractor shall be responsible only for debris that is a result of the work. 6. The contractor shall be responsible for providing temporary facilities and utilities

as required. 7. All dimensions shall be verified in the field before proceeding with the work. The owner shall be notified of any discrepancies, contractor shall request clarification from the designer.

8. The contractor shall be responsible for coordinating the work of all trades and for being aware of all conditions that affect their work. Contractor shall notify owner and designer of any conflicts prior to proceeding with the work.

9. Notify owner and designer, in writing, within three (3) working days of award of contract of the proposed delivery/schedule, of any equipment, finishes, or material for which that schedule may prevent the installation from being completed.

10. Any substitutions must be approved in writing by the designer, proposal for substitution of materials shall meet or exceed the quality of the specified material. 11. Any and all revisions must be approved and authorized by the designer in writing before beginning work.

12. If contradictory situations in the contract documents are discovered to exist, they should be immediately called to the attention of the designer for clarification. 14. They general contractor shall be held responsible or continuous clean-up as the job progresses, and final clean-up upon substantial completion. Continuous cleanup shall keep the job free at all times from unreasonable built-up of debris, wrappers, containers, waste material, etc. which might cause accidents, cause undue hardship on tradesmen and would tend to slow up the job progress. Final clean-up includes cleaning of all surfaces to a "like new" condition and preparing

the project area for its intended use. 15. Shop drawings shall be submitted to the designer for review prior to fabrication and installation.

15. Any penetration to the building exterior enclosure shall be properly sleeved, flashed, counter-flashed, and/or otherwise watertight and weather proof. 16. All electrical work performed on the project shall conform to the N.E.C., UL requirements and local codes.

17. General contractor to obtain all permits necessary.

18. Install all voice, power, and data outlets to noted dimensions. 19. The contractor shall provide all necessary blocking, backing, framing, hangers, or other supports for all finishes, equipment cabinetry, furnishings, and all other

items requiring the same. 20. Seal between ducts and partitions wherever possible.

21. Dissimilar metals shall be effectively isolated from each other to prevent molecular breakdown (galvanic action).


22. The general contractor, subcontractor, or tenant's vendor must certify that all materials and equipment used or installed on this job are free of any asbestos containing materials ("ACM") or polychlorinated biphenyl ("PCBs").

23. Interior wall and ceiling finishes shall comply with IBC flame spread rating.


